

DESCRIPTION

All For Stone™ Algaban™ is a specially designed solution for removing green algae, slime, moss and other plant derived deposits. Highly concentrated for a cost-effective treatment. Product is self-acting requires no scrubbing, is easy to use and has an ongoing regrowth-preventing effect. Particularly useful prior to repainting fence panels and the like. Contains no acids or chlorine. Not suitable for deep-set, ingrained black deposits and the like.

USES

Use on all. Concrete, brick, stone, masonry, render. steps, patios, paths, glass wood fence panels, roofing etc.

TEST FIRST

Due to the nature of different surfaces, you should do several test areas in inconspicuous areas according to the label instructions to determine surface colour stability and desired results. The end user must determine the suitability of the product for their intended use.

PRECAUTIONS

1. Always Test first;
2. Read entire label and product technical bulletin before using;
3. Wear appropriate skin protection;
4. Use when surface temperature is between 4°C and 32°C.

INSTRUCTIONS

1. Shake well before using;
2. Sweep, vacuum, or wipe surface;
3. Dilute with water as follows: 1 part Algaban to 10 parts water (can dilute from 1:5 to 1:20 depending on degree of contamination);
4. Apply to surface with garden sprayer at approx. 0.2 ltrs per m2 (or by watering can)
5. Keep treated surfaces protected from rain for at least 4 hours. Rinse with water after several days.
6. Allow 24 to 48 hours for results to begin to show

LIMITATIONS

- Do not allow product to come in contact with any non-recommended surfaces.

COVERAGE

Up to 150 m2 if applied by sprayer or 50m2 if applied directly by watering can

HANDLING AND STORAGE

- Close container tightly after each use.
- Store in original container only.
- Store in temperatures between 4°C and 32°C.
